

**SECOND AMENDMENT TO THE  
MASTER LICENSE, SERVICES, AND SUPPORT AGREEMENT**

between

**COUNTY OF SANTA BARBARA**

and

**COLORADO CUSTOMWARE, INC.**

**THIS IS THE SECOND AMENDMENT** (hereafter "Second Amendment") to the Master License, Services, and Support Agreement, contract number BC 10-147, entered into as of May 25, 2010, by and between the **County of Santa Barbara**, a political subdivision of the State of California (hereafter "JURISDICTION") and **Colorado CustomWare, Inc.** (hereafter "CONTRACTOR"), having its principal place of business at 1109 Oak Park Drive, Fort Collins, CO 80525 (hereafter "Agreement").

**WHEREAS**, JURISDICTION and CONTRACTOR wish to extend the project implementation timeline and increase the maximum contract amount of the Agreement to \$1,701,240, including all prior amendments.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, JURISDICTION and CONTRACTOR hereby agree as follows:

**Amendments**

**THE AGREEMENT IS AMENDED AS FOLLOWS:**

**1. In Section 8, Subsection A is amended to read as follows:**

For CONTRACTOR license, services, and support to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed \$1,701,240 (does not include FieldWare) which includes support through 06/30/2015 and the cost of the Matix module added in the first contract amendment .






