


August 3, 2010 BOS Hearing

- NextG Proposal (also in Aug. 24, 2010 letter):
 - Vault 6 sites (if feasible)
 - If approved, withdraw 2 remaining sites

Vaulting Feasibility Results

- Vaulting feasible at all 6 sites, however:
 - Some vegetation removal required
 - Retaining wall required at 2 locations


