

**AMENDMENT NO. 1
TO AGREEMENT FOR PROFESSIONAL SERVICES WITH CANNON CORPORATION
FOR THE DESIGN OF NEW SLUDGE DRYING BEDS AND RETURN FLOW SYSTEM AT
THE LAGUNA COUNTY SANITATION DISTRICT**

THIS AMENDMENT, effective as of the date last written below, is entered into between the Laguna County Sanitation District, a dependent special district of the County of Santa Barbara, a political subdivision of the State of California (hereinafter COUNTY) and CANNON CORPORATION, having its principal place of business at 1040 Southwood Drive, San Luis Obispo, CA 93401 (hereafter CONTRACTOR).

WHEREAS, the parties hereto, on July 10, 2012, entered into an agreement (BC13-030) for performance of professional services by CONTRACTOR in connection with the Laguna County Sanitation District Sludge Drying Beds Project; and

WHEREAS, the original agreement amount for said services was in the not to exceed amount of \$107,382; and

WHEREAS, a proposal for this work has been negotiated with CONTRACTOR and found to be appropriate;

NOW THEREFORE, the parties hereto agree as follows:

- A. The additional statement of services shown on Exhibit 1, attached hereto and incorporated herein by this reference, is hereby, added to the previously agreed upon Scope of Work:

Contractor shall perform additional design work including:

1. Revise pump station design to accommodate a duplex system.
2. Addition of a vacuum truck grit dump station.
3. Design for placement of additional paving.
4. Preparation of a stormwater pollution prevention plan.

- B. Contractor hereby agrees to accept the following as full and final compensation for the Scope of Work as amended herein:

1. Compensation for additional services in the amount of \$5,178 for the items above.
2. CONTRACTOR shall be paid a total contract amount, not to exceed \$112,560.

- C. In all other respects the contract shall remain in full force and effect.
