Santa Barbara County Supervisors,

The following information was obtained through a very cursory review of public records associated with Mr. Dilip Ram of Spectra America (Proposed Transferee for the Santa Barbara Ranch Inland Development Agreement) in US Bankruptcy Courts. It appears there are perhaps 30-40 bankruptcy case filings of affiliated entities of Mr. Dilip Ram including his personal bankruptcy case. Attached are only a sampling of documents for reference. It is not entirely clear the status of all cases as reviewing the financial aspects of Mr. Dilip Ram and his affiliated entities would mean reviewing thousands of pages of documents in complex bankruptcy cases. In order to consider whether the transferee is acceptable for the County it must consider both financial and reputational aspects of the transferee. A thorough review of the information available on Mr. Dilip Ram and Spectra America will take valuable and extensive staff time and resources, especially since the transferee has submitted no information for review. The attached information offers **only a glimpse** at the financial and reputational fitness of the transferee.

After taking into account money drawn down to pay prepetition invoices and money returned to or for the benefit of the Debtors, as of the Petition Date, \$444,141.25 of this amount remained on deposit as a retainer for services to be provided and expenses to be incurred in connection with this chapter 11 case (the "Retainer"). The Retainer is on deposit in an attorney-client trust account and serves as a security retainer to secure payment of Lesnick's allowed fees and expenses.

Lesnick has agreed to accept as compensation for his services the Retainer and such additional sums as may be allowed by the Court. No additional compensation will be paid by the Debtors to Lesnick except as approved by the Bankruptcy Court.

Until the Retainer is exhausted, Lesnick has proposed to draw his fees and expenses from the Retainer on a monthly basis in accordance with the procedure set forth in Section II.B of the *Guide to Application for Employment of Professionals and Treatment of Retainer* ("Compensation Guide") promulgated by the Office of the United States Trustee, as will be set forth in more detail in the application to employ Lesnick as bankruptcy counsel. After exhausting the Retainer, Lesnick will file one or more fee applications seeking Court authority to receive compensation and reimbursement of expenses from the Debtors consistent with any orders of the Bankruptcy Court and applicable procedures established by the Office of the United States Trustee.

Lesnick has not agreed to share the compensation received in connection with this case with any person unless they employed in Lesnick's office.
