That the Board of Supervisors:

B. Authorize the Chair to execute the Notice to Property Owner for APNs: 129-110-24 and 129-210-26 to record on the title of each property that surface mining will occur as described in the Land Use Permit.

1997 (corrected 11/3/98). The mining operation is located in and adjacent to the Santa Maria and Sisquoc Rivers.

The agreement will provide that Hanson Aggregates Mid-Pacific, Inc. (Owner/Operator) will be responsible to design, construct, maintain, repair, and replace the mining basin facilities. In addition, the agreement also indemnifies and holds harmless the County and the District from any liability associated with the approval, construction, operation, use, maintenance, and monitoring of basin facilities.

Prior to the beginning of any mining or reclamation of the basins, the Maintenance Agreement and the Notice to Property Owner will be recorded.

Direction by the Board will not change programs and service levels.
