The County of Santa Barbara proposes to reconfigure the intersection of Foxen Canyon Road at Santa Maria Mesa Road from a "Y" intersection to a "T" intersection. The reconfigured intersection will modify the south leg of Foxen Canyon Road by bending it to the north-east as it approaches Santa Maria Mesa Road which will create a 90 degree "T" intersection. As a result the intersection will be relocated to a point approximately 150 feet southeast of its original location along Santa Maria Mesa Road. All work will be within the County road right of way.

Cite specific CEQA Guideline Section __15301 (c) Existing Facilities - "...consists of the operation, repair, maintenance, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that previously existing, including but not limited to:...(c) Existing highways and streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities (this includes road grading for the purpose of public safety), except where the activity will involve removal of a scenic resource including a stand of trees, a rock outcropping, or an historic building.

Reasons to support exemption findings: The project is a repair of an existing County roadway and therefore is contemplated by the CEQA exemption under section 15301. Further, there are no unusual circumstances which would create a possibility that there would be a significant effect. Because this is a public road project outside of the Coastal Zone it has been determined to be exempt from the Land Use Development Permit requirements by ordinance, under Section 35.10.040 G (b) of the Land Use Development Code. The project is maintenance activity designed to maintain a safe traveling condition of the highway facility as it was constructed.
