Recommended Actions:

That the Board of Supervisors adopt the attached Resolutions (3), establishing car share parking zones on Pardall Road, Embarcadero del Mar, and Camino Pescadero in Isla Vista; Third Supervisorial District.

Summary Text:

In accordance with the Isla Vista Master Plan Parking and Transit Policy 4 and Ordinance No. 4742, the Redevelopment Agency and the Public Works Department have been finalizing the locations for reserve parking spaces in the Isla Vista community that would be appropriate for use for the three-year car share pilot program. The Redevelopment Agency and the Public Works Department reviewed locations within Isla Vista and determined that the most appropriate locations would be those that had been recently abandoned by MTD as a result of changes in their bus routes. These nine parking spaces were already designated as No Parking, so there will be no net loss of parking spaces in Isla Vista as a result of this action.

The Redevelopment Agency and the Public Works Department have received a request for four of these locations from Zip Car. We have reviewed Zip Car's application and have determined that it meets the requirements approved in Resolution No. 10-050. By approving the attached resolutions for nine parking locations, Zip Car will have the use of four of these parking locations, while the other identified locations will be available if Zip Car wishes to expanded their service in the future or if the County receives an application from another car share provider in the future.

The Public Works Department has prepared the attached Resolutions establishing parking restrictions at the following locations:

ADOPT

Car Share Parking Zone

- On the north side of Pardall Road from a point 219 feet east of the centerline of Embarcadero del Norte to a point 309 feet east of the centerline of Embarcadero del Norte and (4 parking locations)
- On the west side of Embarcadero del Mar from a point 46 feet north of the centerline of Trigo Road to a point 80 feet north of the centerline of Trigo Road and (2 parking locations)
- On the west side of Camino Pescadero from a point 103 feet north of the centerline of Abrego Road to a point 180 feet north of the centerline of Abrego Road (3 parking locations)

Background:

On February 23, 2010, the Board of Supervisors approved Ordinance 4742 which amended Chapter 23 of the County Code to permit car share parking zones in the Isla Vista Master Plan area for a three-year pilot program. The attached three resolutions identify specific parking locations that were deemed appropriate for car share use. The Redevelopment Agency and the Public Works Department have identified three locations with a total of nine parking spots that could be available for the three-year car share pilot program. Zip Car has requested the use of four of these identified locations for use immediately. The remaining locations would be available if Zip Car decides to expand their operation or if another car share provider were to request an encroachment permit and meet the County's car share guidelines as set forth in Resolution No. 10-050.
