On April 27, 2010, the Governor of California proclaimed and ordered that a special general election be held on August 17, 2010 within the 15th Senate District to fill the vacancy resulting from the resignation of Abel Maldonado who was appointed to Lieutenant Governor. Per Election Code Section 10704, a special primary election must be held eight weeks prior to the special general election. This requires the County to conduct a special primary election on June 22, 2010. The cost estimate for each special election is \$530,000. This budget revision establishes \$530,000 in appropriations for the cost of the June special primary election in the current fiscal year, including \$10,000 for security services from the Sheriff's Department, and funding sources from the Contingencies fund (\$350,000) and (\$180,000) from the CRA's Election Designation Account (LIA 9742). The funding request for the August 2010 Special General Election is being requested with a budget adjustment for approval during the Fiscal Year 2010-11 budget hearings.
