## **RESOLUTION NO. 10-849**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLVANG SUPPORTING THE ADOPTION BY THE SANTA BARBARA COUNTY BOARD OF SUPERVISORS OF A SOCIAL HOST LIABILITY ORDINANCE

WHEREAS, underage drinking is a growing problem nationally and locally with devastating consequences costing more than 53 billion dollars (\$53,000,000,000) annually according to data from the Institute of Medicine of the National Academies; and

WHEREAS, seventy percent (70%) of 11<sup>th</sup> graders at Santa Ynez Valley Union High School report that they have used alcohol and another fifty-two percent (52%) report having been very drunk or sick after drinking; and

WHEREAS, alcohol use by young people is extremely dangerous, not only to themselves – but to society as a whole and is a major factor in motor vehicle crashes, homicides, suicides, and unintentional injuries, which are some of the leading causes of death among youth; and

WHEREAS, alcohol is the number one drug of choice for America's young people and is associated with traffic fatalities, violence, unsafe sex, suicide, educational failure and other behavioral problems; and

WHEREAS, every day in the United States, 7,000 children under the age of 16 take their first drink; and

WHEREAS, thirty eight percent (38%) of our local high school students report using alcohol prior to age fifteen (15); and

WHEREAS, those who start drinking before the age of 15 are four times more likely to become alcoholics than those who begin at age 21; and

WHEREAS, students county-wide report that alcohol is very easy to obtain and is most frequently available at private parties hosted by both minors and adults who provide places and locations for underage to drink; and

WHEREAS, law enforcement reports that current laws are insufficient to curtail these parties and hold those hosting them accountable before the law; and

WHEREAS, a social host liability law will hold a person, who knowingly hosts a party or other gathering where underage age drinking takes place, responsible through monetary penalties; and

WHEREAS, social host liability laws that have been adopted by numerous local governmental jurisdictions nation-wide and in California have proven successful, at low costs, in deterring underage drinking by reducing the accessibility of alcohol to those underage; and

WHEREAS, all local governmental agencies within Santa Barbara County should speak with a loud and single voice against the use of alcohol by those underage; and

WHEREAS, social host liability laws will be most effective if all local government agencies within Santa Barbara County that share mutual boundaries share a consistent law enforcement approach; and

WHEREAS, it is the intention of the City Council of the City of Solvang to adopt its own social host ordinance by utilizing the ordinance adopted by Santa Barbara County as a model;

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Solvang urges the Board of Supervisors to adopt a social host liability ordinance as soon as possible to help in reducing underage drinking.
