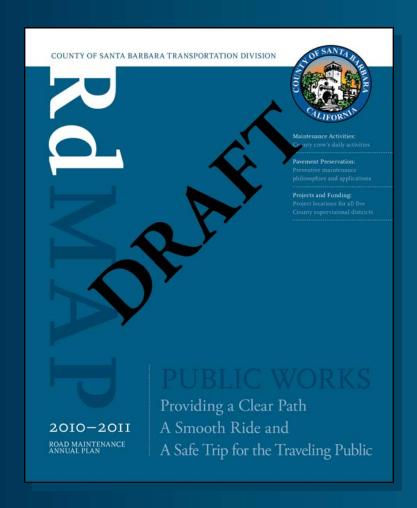


Mission Statement

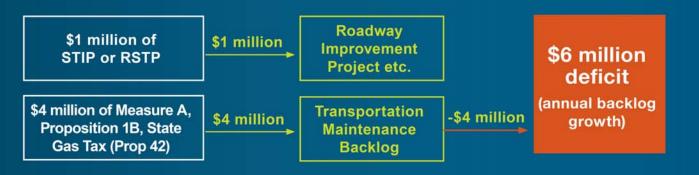
- 1. Modest Decrease this year over last year due to influx of ARRA funding and continued decrease in oil prices on the worldwide market and the Department's commitment to continuing to search out cost effective surface treatments
- 2. An Increase could occur next year due to decrease and uncertainty in State and Federal Revenues for Pavement Preservation and the continuing decline of our roads that are not in a state of Pavement Preservation

Staff Recommendations

- Adopt the FY 2010/11 Road Maintenance Annual Plan
- Approve the funded projects listed for Maintenance Program
 (County Forces) and Surface Treatment Program (Contracts/County Forces) within the Road Maintenance Annual Plan
- Approve the filing of a Notice of Exemptions pursuant to the County's California Environmental Quality Act (CEQA) Guidelines Section 15301(c), pertaining to operations and maintenance of existing facilities for the above; (POST)
- Authorize the Director of Public Works to advertise the above mentioned projects contained within the FY 2010/11 Road Maintenance Annual Plan
- Reprogram 2007 Proposition 1B funds in the amount of \$350,000 from the Tepusquet Road Bridge to the Cottonwood Canyon Road paving project
