Approved a partial settlement agreement in County of Santa Barbara v. Elings Park Foundation, SBSC #1343634. That litigation involves County's enforcement of a restrictive covenant that County previously obtained in exchange for \$525,000 of Coastal Resource Enhancement Grants. Under the partial settlement agreement that is being filed with the Superior Court, County will allow the June 5-6 Bicycle Festival to occur this year, in exchange for Elings Park Foundation placing restrictions on the operation of this year's Bicycle Festival, including:

- The "staging" for bicycle races will occur on Elings Park North;
- Parking on Elings Park South will be limited to 60 vehicles;
- No amplified sound will be allowed on Elings Park South;
- · No "beer gardens" will be allowed on Elings Park South; and
- No new bicycle trails will be constructed on Elings Park South.

Elings Park Foundation will provide a \$10,000 letter of credit to guarantee the above restrictions. The partial settlement agreement provides that the County is still litigating this enforcement case, but within the normal timeframe for Superior Court litigation.
