Alignment with Board Strategic Plan:

The recommended actions are primarily aligned with actions required by law or by routine business necessity. They are also aligned with the Board's adopted Goal #1: An efficient Government able to anticipate and respond effectively to the needs of the community.

Executive Summary and Discussion:

On September 20, 2004, the Legislative Program Committee met, and discussed the sixteen Statewide Initiatives which will appear on the November 2, 2004 Ballot. Based on their review and discussion of the Initiatives, the Committee directed staff to forward the above recommendations to the Board of Supervisors. The Committee membership is as follows: Second District Supervisor Susan Rose, Third District Supervisor Gail Marshall, County Administrator Michael F. Brown, County Counsel Stephen Shane Stark, and County Auditor Controller Bob Geis. Please note. On August 3, 2004, the Board voted to Support Proposition 63 – Mental Health Services Expansion, Funding. Tax on Personal Income above \$ 1 Million.

Attached is a brief summary, in spreadsheet form, of each of the Statewide Ballot Initiatives (Attachment A). A copy of the Official Ballot Measure Summary, from both the Voter Information Guide (Attachment B) and the Supplemental Voter Guide (Attachment C - which contains Proposition 1A and Proposition 65).
