Recommended Actions:

The Board of Supervisors set a hearing for November 20, 2007 to direct the County Water Agency to invite other South Coast agencies and municipalities to form a regional multi-agency watershed task force that will compile an inventory of past and ongoing watershed planning and protection efforts. After compiling this data, staff will perform an evaluation and provide findings based on the data collected. Estimated time for the hearing is 30 minutes.

Summary Text:

In the effort to address this need for collaborative data sharing and analysis, County Water Agency staff, through the Project Clean Water Program, will take the lead in developing a South Coast Watershed Task Force comprising other representatives from South Coast agencies to develop an inventory of work that is being done by the County and other agencies within watersheds.

Specifically, the goal of this task force is to develop a regional approach to watershed planning in the South Coast by bringing together all South Coast jurisdictions to assess what is taking place within the watersheds, what resources are being allocated and by whom. This will provide information that can ultimately be used to enhance delivery of services, increase efficiency, identify any duplication of effort in the region and make our County more competitive for State and Federal grant opportunities, including Proposition 84 dollars. The data gathered may also be incorporated into potential future revisions to the Integrated Regional Water Management Plan.

The data will be collected through a review of existing reports and interviews with key agency staff and include California State Parks and the Southern California Wetlands Recovery Project. The County has been a member of the SCWRP since its inception in 1997.

Background:

Currently, there are significant resources dedicated by local governing agencies and other organizations to data gathering, watershed planning, and watershed protection. We are aware of watershed based evaluations performed by the CRCD, the County as well as the Cities of Carpinteria and Santa Barbara. These efforts have generally focused on one watershed at a time.

A review of these activities will provide the history of work completed in recent years and can lead to an understanding of possible benefits from additional work and make us more competitive for state funding opportunities. Other municipalities have expressed an interest and willingness to participate in the Task Force.
