SUBJECT: Juvenile Accountability Block Grant for FY 06-07

Recommendation(s):

That the Board of Supervisors:

Adopt the attached resolution authorizing the Chief Probation Officer to submit, sign, and accept the Juvenile Accountability Block Grant (JABG) in the amount of \$33,354 for the period July 1, 2006 to June 30, 2007 from the California Corrections Standards Authority (CSA).

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit and with Goal No. 7. A Community that Fosters the Safety and Well-Being of Families and Children.

Executive Summary and Discussion:

The Probation Department has been receiving Juvenile Accountability and Incentive Block Grant (JAIBG) funds from the Office of Criminal Justice Planning (OCJP) since FY 1999-00. Due to the creation of the Department of Homeland Security and the restructuring of the Federal Government that resulted, the OCJP ceased to exist as of September 30, 2003. In December 2003, the Probation Department was notified that the new administrator of the grant would be the Board of Corrections (BOC) which was renamed the Corrections Standards Authority starting in FY 2005-06. The Federal Government renamed the grant program the

Juvenile Accountability Block Grant (JABG) during the FY 2004-05 application period. Hereafter the program will be referred to as JABG regardless of the fiscal year. The eligible program areas remained the same.

In the past, JABG has been used to fund activities designed to improve and expand the Probation Community Service Work Programs, help fund the development of the Juvenile Client Management system, to provide services to minors participating in the Juvenile Drug Court program, and to fund Teen Court services for minors in the three geographic regions of the County. The Juvenile Justice Coordinating Council (JJCC) has agreed that the FY 2006-07 grant will be used to fund services to minors participating in the Juvenile Drug Court, alcohol and drug orientation and counseling at the juvenile halls and to provide Teen Court services.

The Performance Measures for the Juvenile Drug Court Program are:

- RPM # 89: Ensure that 70% of approximately 75 participants in Juvenile Drug Court will not have positive drug screens measured on a quarterly basis.
- RPM # 117: Ensure at least 50% of 75 youth enrolled in the Juvenile Drug Court (JDC) graduate from the program.

The Performance Measure for the Teen Court Program is:

• Ensure that at least 80% of Teen Court graduates do not have a new felony or misdemeanor referral within six months of graduation.

Mandates and Service Levels:

Statutory mandates governing Probation Department services are attached for your review.

Fiscal and Facilities Impacts:

The JABG grant funds ongoing Probation Department programs. Components of the Juvenile Drug Court program that were previously grant funded and considered core to the program were included in the FY 06-07 County Proposed Budget, albeit at a reduced grant award level (i.e. \$33,354 for FY 06-07 versus \$37,581 for FY 05-06). The grant maintains a 10% cash match requirement and is calculated against the combined grant award and match financing (i.e. 10 % of \$37,060 = \$3,706 match). This year's match is \$470 less than last year's match and is already included in our FY 06-07 Proposed Budget. As in previous fiscal years the match financing consists of County General Fund contribution, however, there is no increase in General Fund contribution for FY 06-07 relative to the current fiscal year.

There will be no anticipated facility impacts. The project will use existing facilities.
