Sheriff: Increase appropriations Santa Maria Branch Jail by \$25,116 from the Contingency Fund to build visitation and recreational facilities to allow for the reclass of the facility to a Type II facility.

The Santa Maria Branch Jail (SMBJ) is currently a Type I facility that is allowed to house inmates for a period of no more than 96 hours. Any inmates to be incarcerated for longer than 96 hours are transported to the Santa Barbara Mail Jail (SBMJ). By reclassifying the SMBJ to a Type II facility, inmates can be housed there for up to one year, similar to the SBMJ. This revision draws from the Contingency Fund a total of \$25,116 to upgrade facilities necessary to upgrade the SMBJ to a type II facility. This will add anywhere from 9 to 17 extra beds to house inmates, decreasing the need for floor sleepers.
