

SANTA BARBARA COUNTY BOARD OF SUPERVISORS NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Board of Supervisors of the County of Santa Barbara, State of California, on October 10, 2023, to consider case No 23APL-00023, an appeal of the County Planning Commission denial of the North Fork Ranch Frost Ponds Project, Case Number 16CUP-0000-00005.

The project is a request by Brodiaea, Inc. (property owner/applicant) for approval of a Minor Conditional Use Permit (CUP) for the construction and operation of three water reservoirs and associated piping for frost protection at the North Fork Vineyard. Each reservoir would have a storage capacity of approximately 44-acre feet and would occupy an area of approximately five acres. A total of approximately 257,945 cubic yards of cut and fill grading would be required to construct all three proposed reservoirs. The project site is located approximately nine miles west of the community of New Cuyama between Cottonwood Canyon Road and Schoolhouse Canyon Road, First Supervisorial District.
