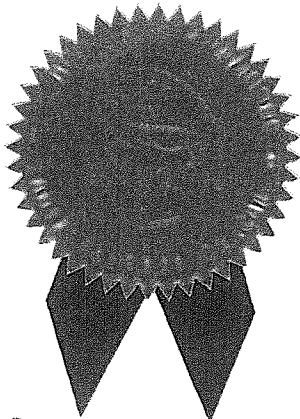

He also facilitated leadership courses for a variety of Probation Departments in the state; and

WHEREAS Manager Clark is looking forward to spending time with his wife Julie, going on camping trips, and visiting each of their three children, Fayth, Destinee, and Luke. He is also excited to assist the new Manager and Deputy Chief as they work toward expanding programming and treatment options at the Juvenile Justice Center as he transitions into retirement.
