**WHEREAS**, the Code of Santa Barbara County, California, Section 23-11, authorizes the Board of Supervisors of the County by Resolution, to designate portions of roads and highways under its jurisdiction as No Parking or Time-limited Parking Zones; and

**WHEREAS**, it appears to be in the best interest of public safety that certain portions of County streets or highways in Santa Barbara County be designated as No Parking or Time-limited parking zones, in accordance with said Section; and

**NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED**, that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as a No Parking or Time-limited Zones:

No Parking Zone

- On the south side of Venice Lane from the centerline of Santa Monica Road to a point 90 feet west of the centerline of Santa Monica Road establish no parking anytime for vehicles that are 6 feet or more in height (including any load thereon).
- On the north and south side of Calle Carida from the centerline of Cieneguitas Road to its western terminus establish no parking 2 a.m. to 6 a.m.
- On the south side of Trigo Road from the centerline of Embarcadero Del Norte to a point 122 feet east of the centerline of Embarcadero Del Norte establish no parking anytime.
- On the south side of Trigo Road from 196 feet east of the centerline of El Embarcadero to a point 240 feet east of the centerline of El Embarcadero establish no parking anytime.
- On the south side of Trigo Road from the centerline of El Embarcadero to a point 56 feet east of the centerline of El Embarcadero establish no parking anytime.
- On the east side of Refugio Road from the centerline of Horizon Drive to a point 158 feet south of the centerline of Horizon Drive establish no parking anytime.

Time-Limit Parking Zone

- On the north side of Padaro Lane from a point 1543 feet south and east of the centerline of Via Real to a point 2524 feet south and east of the centerline of Via Real, prohibit parking altogether during the hours between sunset and sunrise.

- On the south side of Trigo Road from a point 56 feet east of the centerline of El Embarcadero to a point 158 feet north of the centerline of El Embarcadero establish a 60 minute parking zone between the hours of 9:00 a.m. and 6:00 p.m. except holidays and Sundays.
- On the south side of Trigo Road from a point 158 feet east of the centerline of El Embarcadero to a point 196 feet north of the centerline of El Embarcadero establish a 15 minute parking zone between the hours of 9:00 a.m. and 6:00 p.m. except holidays and Sundays.

**IT IS FURTHER RESOLVED**, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signs as time and resources permit.
