Reasons to Support Exemption Findings: Section 15270 of the CEQA Guidelines states "CEQA does not apply to projects which a public agency rejects or disapproves." This statutory exemption is intended to allow an initial screening of projects on the merits for quick disapprovals prior to the initiation of the CEQA process where the agency can determine that the project cannot be approved.

The owner submitted an application to nominate the Bryce Beach Cabana and Funicular as a Historic Landmark on March 10, 2011. According to Section 18A-2 of the County Code, the Historic Landmarks Advisory Commission designated the Bryce Beach Cabana and Funicular as a Historic Landmark on June 13, 2011. Section 18A-5 of the County Code states that the Board of Supervisors may "approve, modify or disapprove the designation by the commission . . ." The Board of Supervisors disapproved the designation on September 6, 2011. This action rejected

and disapproved the designation and, therefore, is exempt from the provisions of CEQA consistent with Section 15270 of the CEQA Guidelines.
