That the Board of Supervisors:

- a) Adopt the attached resolution to authorize the submittal of an application for the Department of Resources Recycling and Recovery's (CalRecycle's) SB 1383 Local Assistance Grant Program (FY 2021/22) in the estimated amount of \$175,921 and authorize the acceptance of said grant; and Find that the proposed resolution does not constitute a "Project" within the meaning of the California Environmental Quality Act, pursuant to 14 CCR 15378 (b)(5) (administrative activity of government).

Summary Text:

The Resource Recovery and Waste Management Division of the Public Works Department proposes to submit an application to the Department of Resources Recycling and Recovery (CalRecycle) for the SB 1383 Local Assistance Grant Program (FY 2021/22) in the estimated amount of \$175,921. If awarded, the grant will fund activities to implement and achieve compliance with California's Short-Lived Climate Pollutant Reduction Strategy regulations, otherwise known as SB 1383. The grant covers a two-year term and will fund two key areas: 1) education and outreach, and 2) facility sampling and compliance.

Education and outreach activities will include direct mail, advertisements, press releases, social media posts, and participation at community events to educate residents and business owners about the new

programs to divert organic waste from the landfill. Facility sampling will entail testing loads of solid waste at designated collection facilities to determine the percentage of organic waste being recovered.

Background:

CalRecycle is administering a one-time grant program intended to aid local jurisdictions with the implementation of SB 1383, legislation passed in 2016 aimed at reducing the landfilling of organic waste. The regulations began on January 1, 2022 and require significant resources to comply with the various requirements. The non-competitive Local Assistance Grant will provide funding for compliance activities such as collection, education and outreach, edible food recovery, capacity planning, recordkeeping, and enforcement and inspection, among other areas.
