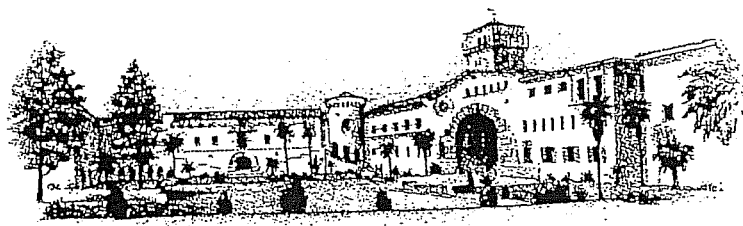

WHEREAS, the Public Health Department will rename the Specialty Clinic in Santa Barbara to the Stephen R. Birch Specialty Wing; and

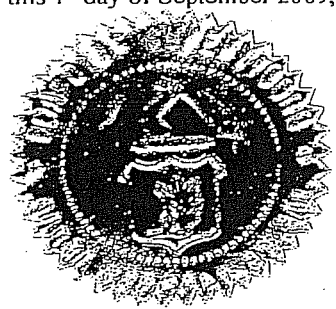
WHEREAS, the Public Health Department wishes to recognize all providers who have provided affordable quality healthcare to our patients; and
