I have been a Santa Ynez Valley resident for 28 years, graduated from UCSB in 1990, and have worked the majority of my career at UCSB. I have actively enjoyed the trails and roads in the Santa Ynez Valley and Santa Barbara South Coast as a road cyclist, mountain biker, trail runner, road runner, and occasional hiker. I am a recent empty nester (both kids have graduated from Cal Poly - yay!) and have some extra bandwidth to take on some community service in a topic that I have benefitted from but not made any significant contributions to. For me, it's time to give back and do what I can to make improvements for future users. I have a particular interest in open space access in and around the SYV, including but not limited to, the realization of the long overdue "river trail." I attended a community meeting recently in Solvang regarding the river trail, and was inspired by loan's (and other community leaders' work) to bring this to an eventual reality. I also have recently enjoyed an outing with loan at the Trails Day hike at the Naples property on the coast, participated in a trail running event at Baron Ranch (the first time I've visited that site - amazing), and also took a docent led hike at Arroyo Hondo (also a first for me - spectacular!). I am very inspired by semi-recent mountain bike trail development at Lake Cachuma (I participated in one of the trail building days there a couple of years ago) and the brand new Trek Trails at Rancho Allegre. I am a firm believer in shared use and access to various trails, and understand some of the conflicts that arise with the varying groups. As a long time mountain biker, I've always followed the general rule of yielding to hikers and horses, and use a bell for my downhill jaunts, but also have found myself frustrated with equine use, especially when otherwise amazing mountain bike trails have been torn up by horse hooves following rain (case in point, Camuesa Connector trail out off Paradise Rd.). I'm sure the equine community has equal frustrations about mountain bikers, and my desire would be to work together as a community to bring the various constituencies together to find common ground in order to move forward with our mutual desires for more access to trails and open space. As a road cyclist in the SYV, I am in awe of all the wonderful places we locals and visitors alike can ride, however I am equally dismayed by the sad state of the tarmac on the roads, and the debris (glass, rocks, gravel) that constantly creates hazards in the designated "bike lanes" that accompany our main roads forcing us to ride dangerously close to (or sometimes among) the vehicle traffic. I am a member of the SYVCC (cycling club) and participate in road cleanup efforts on Armour Ranch and Happy Canyon, but would like to do more to leverage public efforts and funds to improve the state of our roads for cyclists. Finally, I would love to see more private/public partnerships to allow easements and access to the beautiful open space that surrounds our communities. I see San Luis Obispo as a model of what could be possible in our community.
