The purpose of Phase 2 of this project is to develop construction documents, project cost estimates, provide environmental assessments, and entitle the necessary easements or right of ways to install the new water and wastewater systems for the Bridge House Homeless Shelter (the Shelter) and the Santa Barbara County Road Yard. The facility is currently on a domestic well and septic systems, both of which are failing and have required an elevated level of service over time, also limiting the potential expansion of the complex needed to address people experiencing homelessness. The design consultant, a civil engineer specializing in wet utility design, is being retained by General Services and will provide the necessary services to get the project to the construction phase.

However, it is important to note that any CEQA exemption applies only to CEQA and not, of course, to any other state, local or federal laws that may be applicable to a proposed project.
