That the Board of Supervisors:

1. Reappoint Suzanne Grimesey-Kirk, Division Manager of Children's Services as an Interim Commissioner representing Alcohol Drug and Mental Health Services, and the Director of Social Services Kathy Gallagher, as regular "County Members" of the First 5 Santa Barbara Children and Families Commission from the term July 1, 2010 to June 30, 2011.
2. Reappoint Patti Stewart Chief Probation Officer from the Probation Department as alternate "County Member" of the First 5 Children and Families Commission for the term of July 1, 2010 to June 30, 2011

Background:

Until September 2009, Dr. Elliot Schulman from the Public Health Department served as a Commissioner on the First 5 Santa Barbara County Commission. The Interim Director serving the department during the recruitment process for a new Director was Dr. Peter Hasler. On September 15, 2009 Dr. Peter Hasler was appointed to serve as Interim Commissioner representing the Public Health Department until the new director was hired. On May 4, 2010 Dr. Takashi Wada was appointed to serve as the County Health Officer to the Commission by the Board of Supervisors term to expire June 30, 2011.

First 5 Santa Barbara County, Children and Families Commission consists of nine regular and four alternate members appointed by the Board of Supervisors. One regular member of the Board of Supervisors and three regular members are “County Members” selected from among the County Health Officer, and the Director of Social Services, and the Director of Alcohol, Drug and Mental Health Services, and the Director of Probation. One permanent position on the Commission is the County Superintendent of Schools, and two members are from the “Community At Large”. One Alternate member is a member of the Board of Supervisors, one Alternate is a “County Member” and two Alternates are from the “Community at Large”.

The Current regular “County Members” are the Interim Director of the PHD, Peter Hasler, M.D., and the Director of Social Services, Kathy Gallagher. The Director of Alcohol Drug, and Mental Health Services, James L. Broderick, Ph.D. served as Commissioner until his retirement in March 2007. At that time Suzanne Grimmesey-Kirk was appointed by the Board of Supervisors to represent ADMHS. Patti Stewart, Chief Probation Officer, serves as the Alternate “County Member.

Performance Measure:

The members of the First 5 Children and Families Commission will be required to devote a substantial amount of time attending monthly Commission meetings, and evaluating future funding proposals, monitoring outcomes of existing grants, and ongoing Strategic Planning.
