To Supervisor Das Williams, the Cannabis Regulation and Licensing Department and the Santa Barbara Board of Supervisors:

On August 12, 2020, we sent to you a petition signed by 165 signatures/names of concerned business property owners, homeowners of Santa Claus Lane, Padaro Lane, Carpinteria, Beach Club Road, Sandpoint who oppose the placement of a cannabis retail storefront.

We now understand that there are 2 locations that have passed Phase I of the merit-based selection process. They are at 3823 and 3825 Santa Claus Lane in Carpinteria.
