Summary Text:

This item is on the agenda in order to accept easements for Public Utility purposes offered on Parcel Map No. 14,720. The County Surveyor's Office has reviewed Parcel Map No. 14,720 (County Assessor Parcel Number 137-081-012), located at 1683 Alamo Pintado Road, in the Solvang area, Third Supervisorial District.
