#### SECOND AMENDMENT TO AGREEMENT

between

### **COUNTY OF SANTA BARBARA**

and

#### CITY OF LOMPOC

for

#### ANIMAL CONTROL SERVCES

Effective July 1, 2013

THIS IS THE SECOND AMENDMENT TO THE AGREEMENT (hereafter Second Amendment) for Animal Control Services (hereafter Agreement), made by and between the County of Santa Barbara, a political subdivision of the State of California (hereafter COUNTY), and the City of Lompoc, a municipal corporation in Santa Barbara County (hereafter CITY).

WHEREAS, the parties desire to amend the Agreement to extend the term and to adjust the compensation payable to COUNTY for services performed under the Agreement; and

**WHEREAS**, this Second Amendment incorporates the terms and conditions set forth in the Agreement and First Amendment, except as modified by this Second Amendment.

**NOW, THEREFORE,** for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CITY hereby agree to amend the Agreement as follows:

1. <u>Definitions.</u> Capitalized terms used in this Second Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

# 2. **Amendments.**

The Agreement is amended as follows:

- 5. <u>TERM.</u> The term of this Agreement shall be from July 1, <del>2012</del> **2013** through June 30, <del>2013</del> **2015**.
- 6. COMPENSATION OF COUNTY. For services rendered from the COUNTY operated shelter in Lompoc, between July 1, 2011 2013 and June 30, 2012 2015, CITY shall pay COUNTY \$254,842 a total amount of \$534,338 for the two year period this Agreement is in effect. For Fiscal Year 2013-14, CITY shall pay COUNTY \$262,316, billed in four equal quarterly payments of: \$63,710.50 \$65,579. For Fiscal Year 2014-15, CITY shall pay COUNTY \$272,022, billed in four equal quarterly payments of \$68,005.50. Quarterly payments to COUNTY shall be made within thirty (30) days of receipt of invoice. Invoices shall be delivered to the CITY address specified in Section 3, NOTICES of Agreement.
- 3. <u>Counterparts.</u> This Second Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
