SUBJECT: Stop Control at the Intersection of San Ysidro Road and San Ysidro Lane.
First Supervisorial District.

RECOMMENDATION:

That the Board of Supervisors adopt a resolution establishing a stop control at the intersection of San Ysidro Road (southbound) and San Ysidro Lane in the Montecito area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY AND DISCUSSION:

The intersection of San Ysidro Road and San Ysidro Lane is located between Hwy 192 and East Mountain Drive in the Montecito Area. At this location, San Ysidro Road is a 2-lane collector that runs in a north/south direction and San Ysidro Lane is a 2-lane collector that runs in an east/west direction.

San Ysidro Lane currently has a stop control for westbound vehicles. Vehicles approaching this three-way intersection from San Ysidro Lane (westbound) and turning left (southbound) onto San Ysidro Road have restricted sight distance looking right (northbound) due to thick landscaping along the east side of San Ysidro Road. Based upon our investigation and the sight distance restrictions at this intersection, it was determined that an additional stop control on San Ysidro Road (southbound) would be appropriate. The Public Works, Traffic Section has prepared the attached resolution to establish a stop control at the following intersection:

On San Ysidro Road(southbound) at its intersection with San Ysidro Lane.
