Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with our organizational values regarding collaboration and community assistance.

Executive Summary and Discussion:

The Animal Services division of the Public Health Department has a long-standing commitment to working with the community to better the quality of life for animals received at the County's three animal shelters. The new Santa Maria Animal Center has numerous community organizations and individuals that assist Animal Services in achieving its mission. Some of the organizations donating to complete funding for the shelter are the Wendy P. McCaw Foundation, the Santa Barbara County Animal Care Foundation, the Santa Barbara Humane Society, the Santa Barbara Foundation and the Animal Shelter Assistance Program (ASAP).

As one of its first projects, the Santa Barbara County Animal Care Foundation, Inc. established a goal to assist the County of Santa Barbara with completion of funding for the new Santa Maria Animal Center. Through its efforts of fundraising, special events and grant writing, this foundation has raised over \$980,000 toward the project. Of these funds, \$819,000 is a grant from the Wendy P. McCaw Foundation restricted for the construction of the new Santa Maria Animal Center.

In honor of these commitments, the following naming designations are recommended for portions of Santa Barbara County's new Santa Maria Animal Center: "Animal House, the Wendy McCaw Animal Adoption Center" and the "Santa Barbara County Animal Care Foundation Spay and Neuter Clinic".
