WHEREAS, the Public Health Department, Environmental Health Services is the designated Local Enforcement Agency in Santa Barbara County; and

WHEREAS, as the designated Local Enforcement Agency, the Public Health Department, Environmental Health Services may annually apply for said funds; and

**WHEREAS**, CalRecycle procedures for administering grant programs require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of the grant program.

NOW, THEREFORE, be it resolved that the Santa Barbara County Board of Supervisors authorizes the submittal of annual applications to CalRecycle for Local Enforcement Agency Grants for FYs 2024-25 through 2028-2029; and

**BE IT FURTHER RESOLVED**, that the Director of the Public Health Department, or his or her designee, is hereby authorized as signature authority and empowered to execute, in the name of the County of Santa Barbara, all documents, including but not limited to applications, contracts, agreements, amendments and requests for payment, necessary to secure grant funds and implement and carry out the purposes specified in the application.

**BE IT FURTHER RESOLVED**, that the authorizations for application submittal and said signature authority are effective for five (5) years from the date of adoption of this resolution.
