WHEREAS, Janet has exhibited an unparalleled dedication and commitment to the County of Santa Barbara and the people of the Second District which is only surpassed by her deep love for her family; especially her grandchildren, Avi, Micah, Sophie, and Talya (who will be very excited to see their names here) and, of course her husband of 41 years, Harvey, who will also always be a part of our County family; and
