Recommendation(s):

That the Board of Supervisors:

Approve the attached original and duplicate original <u>Right of Entry Agreements</u> with Union Pacific Railroad Company for the construction of roadway and underpass improvements associated with the railroad underpass on Hollister Avenue at the intersection of Modoc Road and authorize execution thereof by the Chair of the Board.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1. An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

The proposed project is located at Hollister Avenue Bridge 51C-018 east of Modoc Road in the vicinity of the City of Santa Barbara, California.

The proposed project will consist of seismically retrofitting the existing bridge by installing two 60" diameter Cast In Drill Hole (CIDH) piles on the northwest and southeast corners of the existing bridge.

The CIDH piles will be tied to the abutment corners of the existing bridge with a set of structural steel frames.



The attached <u>Right of Entry Agreements</u> provide for the County's entry onto the Union Pacific Railroad property at the project site in order to perform construction activities associated with the seismic retrofitting of the existing bridge.

The terms of the agreement closely follow the standard terms for a Right of Entry Agreement between Caltrans and Union Pacific for work of this nature. As compensation for the granting of the right of entry, the County shall pay the Union Pacific Railroad the sum of Five Hundred Forty-Five Dollars (\$545.00). The expiration date shall be December 31, 2004.

The Transportation Division has reviewed this request and concurs with this real property transaction.

Mandates and Service Levels:

No change in programs or service levels.

Fiscal and Facilities Impacts:

Purchase of the right of entry will cost the County \$545.00. Funds have been budgeted in Dept. 054, Fund 0015, Program 2900, Account 7511.
