#### **Recommended Actions:**

That the Board of Supervisors:

Accept the offer of dedication of 30 feet of Public Road Easement on Riven Rock Road & Hot Springs Road, as offered on Tentative Parcel Map (TPM) 14,644, and as shown on attached "Exhibit A". The subject property is located in the unincorporated area of Santa Barbara.

## **Summary Text:**

The acceptance of this easement will provide the County with a right-of-way width of 55 feet for Riven Road & 60 feet for Hot Springs Road. This dedication will assure a clean and verifiable record of the Public Road Easement. This right-of-way is beneficial to the County in that it allows routine road, utility, and drainage maintenance. No physical change in the existing roadway will occur due to this acceptance of dedication.

#### Background:

TPM 14,644 is currently being plan checked and processed for recordation through the Office of the County Surveyor. The subject right-of-way dedication is consistent with the tentative final map of the project.
