County Counsel reported that by a vote of 5-0, the Board voted in closed session to approve a settlement agreement in the case entitled Maxwell, et al, v. County of Santa Barbara, Santa Barbara Superior Court Case No. 1220506.

Under the terms of the agreement, the parties agreed to the following:

- i) Consistent with the trial court's decision, the Maxwells shall apply to the Surveyor for a voluntary merger of antiquated lots and the issuance of two unconditional certificates of compliance which will result in the right to develop one new home on a roughly .9 acre undeveloped lot.
- ii) County waives the Surveyor's fees for processing applications for certificates of voluntary merger and unconditional certificates of compliance.
- iii) County shall pay the Maxwells \$30,000 (this includes \$5,531.80 for preparation of the administrative record);
- iv) The Maxwells shall dismiss their lawsuit against County with prejudice.
