SUBJECT: Management Study of the County Fire Department

Recommendation:

That the Board of Supervisors set a hearing for April 18, 2006, for one hour to consider the following recommendations:

- A) Receive and file the Management Services Study of the County's Fire Department entitled the "Organizational Review of the County Fire Department;" and,
- B) Direct the County Executive Officer and the Fire Chief to address the study's 47 recommendations as outlined in the attached "Fire Management Study Implementation Matrix" and report back to the Board of Supervisors on any relevant policy-related recommendations as appropriate.

Alignment with Board Strategic Plan: The recommendation is primarily aligned with Goal No. 1. An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion: On November 9, 2004, the Board of Supervisors directed the County Executive Officer to select one department for a Management Services Study (MSS) pilot project. It was determined that the pilot MSS would be of the Fire Department. Accordingly, the County Executive Office formed a project team and contracted with Management Partners, Inc., an outside consulting firm, to produce the aforementioned study (copy attached). The study took place over 8 months, covered all aspects of Fire Department operations and contains 47 recommendations many of which have already been implemented. The attached "Fire Management Study Implementation Matrix" contains each of the recommendations as well as relevant implementation action items, timeframes, departments involved and the current status of each recommendation. A presentation summarizing the recommendations and the status of implementing them will be provided to the Board on April 18.
