SUBJECT: Probation Assistant Addition for Proposition 69 Implementation

Recommendation(s):

That the Board of Supervisors:

Approve the attached Personnel Resolution adding 1.00 FTE Probation Assistant (Class 6051), Range 4654 (\$2,471-\$3,017 per month), effective 8/1/05.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in which to Live, Work, and Visit.

Executive Summary and Discussion:

This action will add one Probation Assistant, fully revenue offset, to assist the Department in meeting the mandates imposed by Proposition 69. Given the current resources, by adding this position, the Department anticipates assessing all currently supervised and new offenders to determine their DNA collection requirements and ensure collection of DNA and palm print submission on all qualifying, currently supervised offenders prior to their probation termination date and new qualifying offenders as they are placed on probation. Using this method it will take approximately five years for the Department to be in full compliance with the new mandates.

Proposition 69, adopted in November of 2004, expands California law enforcement's requirement to collect DNA samples and store genetic information in the California DNA and Forensic Identification Data Base. It requires the collection of DNA samples from: adults and juveniles convicted or adjudicated of any felony offense; adults and juveniles required to register due to a sex or arson offense; and adults arrested for or

charged with felony sex offenses, murder, or voluntary manslaughter (or the attempt to commit such offenses). The list of qualifying offenses is retroactive regardless of when the person was convicted or adjudicated. As a result, DNA samples must be obtained from adults and juveniles already serving time in correctional facilities as well as those who are on parole or probation with a current or prior qualifying offense. The Probation Department estimates that we supervise 5,600 adult and juvenile offenders who meet the Proposition 69 criteria. The collection process requires the submittal of thumb and palm print impressions in addition to a buccal (cheek scraping) specimen.

Initially, the new Probation Assistant will be responsible for assisting in a review of offenders' records to determine whether they qualify for DNA collection and palm print submission. They will also assist in entering the data regarding offender's DNA collection status into the Department's database so that regular reports can be run to assist in prioritizing offenders for collection. Given the current resources and the high volume of offenders requiring collection, sworn officers will need to conduct the bulk of the collection and palm print submissions. However, once data entry of our backlog of offenders is completed, the Probation Assistant will assist with actual DNA collection and electronic submission of palm prints of the offenders who are nearing their probation termination date.

Performance Measure:

- 1. To ensure protection of the public and to enforce court orders: Assess for eligibility 90% of approximately 12,500 offenders for Proposition 69 DNA collection requirements.
- 2. To ensure protection of the public and to enforce court orders: Ensure collection of DNA samples on 90% of approximately 2,075 offenders at either probation entry or termination.

Mandates and Service Levels:

Proposition 69 mandates the collection of DNA samples and submission of palm prints on qualifying offenders as soon as administratively possible. Statutory mandates governing Probation Department services are attached for your review.

Fiscal and Facilities Impacts:

Government Code Section 76104.6 authorized an increased penalty assessment of \$1 for every \$10 or fraction thereof upon every fine, penalty and forfeiture levied on criminal offenses including traffic offenses, but excluding parking offenses for DNA Identification. In FY 05-06 30% of this penalty assessment is allocated to the County and 70% is allocated to the State. Probation will use the revenue from this penalty assessment to fund the position. There will be no increase in cost to the general fund.
