District Sewer Rate Proposal

The Laguna County Sanitation District Board of Directors (Santa Barbara County Board of Supervisors) will be holding a hearing to consider adopting sewer service charge rates for fiscal year 2013-2014 on Tuesday July 2, 2013 at 9:00 am or thereafter at the board hearing room on the 4th floor of the County Administration Building in Santa Barbara. The rates are proposed to increase 11% to provide sufficient revenue to operate the District's wastewater collection, treatment and discharge facilities as well as establish a capital reserve for future upgrades. Residential customers are billed on a flat rate for single family and multiple family units, institutional customers are billed on a per capita basis and commercial customers are billed based on water use and waste strength. A typical household would see an increase of \$5.99 per month. The table below shows the current and proposed rates:

HELP PREVENT SEWER BACK-UPS

Regular Maintenance

Most sewer systems rely on gravity flow to operate. Your sewer lateral, which extends from your building to the sewer main, periodically requires maintenance to help prevent flow obstructions. The age and material of your lateral play a factor but ordinarily roots from trees and shrubs are attracted to water and if your lateral line is cracked, roots will grow towards the water source, enter the lateral line and eventually obstruct flow. Illegal disposal of substances such as grease further contribute to plugging problems. Contact a licensed plumber or drain service for your maintenance needs.

Backwater Valve

Backwater valves are required on lateral lines to prevent sewer back-ups. The District requires backwater valves on all new and replacement laterals. Existing building laterals must have backwater valves if the drainage fixtures are lower than the next upstream manhole cover. Only backwater valves approved by the California Plumbing Code may be used. Installation of such devices requires a permit. You should contact a licensed plumber to determine the need for such a device or, if you already have a backwater valve, to verify that it is in good working order to prevent a back-up.

Additional Measures

Do not dispose of bulky trash items or other trash items through the sewer including toilet wipes or scrubs. Do not dispose of substances such as oil, fat or grease through the sewer. It is against the County Code for anyone to dispose of such substances from whatever source through the sewer. Commercial operations such as restaurants are required to have a grease trap to prevent such an occurrence. Industrial waste generators are required to install a pre-treatment facility to process waste prior to disposal. ** If you are not the property owner and want to protect against potentially uninsurable damage to your personal property, give this notice to your landlord, property manager or property owner.

RECIPE FOR A FAT FREE SEWER

Cooking oil and grease clog sewers. Keep them out of the drain . Or Scrape plates and cookware and pour out all cooking oil and grease into a can or bag and dispose of in the trash. Use

plastic bags to prevent leaks.

Qualifying customer must enter into a 2-year service agreement with Culligan or Rayne. After proof of removal of existing regenerating water softener and a 2year service agreement, the District will deposit \$250.00 to your water softener service account with either Culligan or Rayne. Early termination may result in penalties. For additional questions regarding wastewater treatment and the need to reduce salt, please call the Laguna County Sanitation District at 739-8750.
