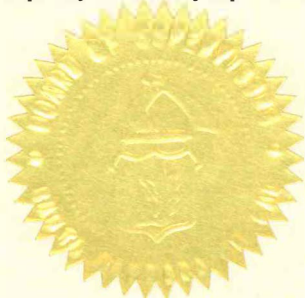
WHEREAS, President Staci Caplan instituted "FlōPlan" and "Glide" as two new member benefits; and
