On behalf of my client and the applicant for the subject Project, we'd like the Board to consider a continuance of Item 5 for tomorrow's hearing. We understand that the appellants may either ask for a continuance in writing today, or at the Board hearing tomorrow.

During the Facilitation meeting btwn the appellant and the applicant this morning, the concept of lowering the roof height was discussed and it will take our design team some time to evaluate how much the roof height could be dropped w/o sacrificing the odor control/HVAC system in the building. It may take us a few weeks to evaluate this on our side, but I'm less certain as to how long it may take to thereafter discuss the potential design change w/ the appellants, ideally in exchange for their withdrawal of the appeal. Therefore it may be best for an indefinite continuance with a future requirement for additional public noticing. I understand the Board needs to vote on a potential continuance and the related matter of whether it's to a date certain.

There were some other more minor site design changes discussed this morning between the parties and we will research those as well, assuming the Board votes for a continuance tomorrow. Thank you and let me know if you need anything further from us or have any questions.
