RESOLUTION OF THE BOARD OF SUPERVISORS COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA

IN THE MATTER OF ESTABLISHING
ELECTRIC VEHICLE CHARGING RATES
AND PARKING FEES AT COUNTY PARKING LOTS

RESOLUTION NO. 25-236

WHEREAS, the County currently owns sixty-six (66) public-facing electric vehicle charging stations in off-street parking facilities owned or operated by the County (each a "County Parking Lot") and plans to add an additional sixty (60) over the next three years; and

WHEREAS, pursuant to California Vehicle Code Section 22519, the County is authorized to adopt a resolution restricting or regulating the parking, stopping or standing of vehicles on any off-street parking facility which it owns or operates (each a "County Parking Lot"); and

WHEREAS, pursuant to California Government Code Section 54037, the County is authorized to impose and collect a reasonable charge for the off-street parking of motor vehicles; and

WHEREAS, on July 14, 2020, the Board of Supervisors adopted Resolution No. 20-145 establishing electric vehicle charging and parking rates and fees relating to public use of electric vehicle charging equipment in County Parking Lots; and

WHEREAS, the Board of Supervisors now desires to delegate to the Director of the County's General Services Department ("General Services Director") the authority to adjust electric vehicle charging station rates semi-annually based on the average unit cost of electricity to the County over the most recent twelve-month period.

NOW, THEREFORE, BE IT HEREBY ORDERED AND RESOLVED by the Board of Supervisors of Santa Barbara County as follows:

- 1. The above recitations are true and correct.
- 2. Designation of Electric Vehicle Parking Spaces. The Director of the County General Services Department, or his designee, is authorized to designate, for the exclusive parking of electric vehicles, stalls in off-street public parking facilities owned or operated by the County that are connected to electric vehicle charging stations for the purpose of transfer of electricity to the battery or other energy storage device of an electric vehicle ("Electric Vehicle Charging Station Stalls").
- 3. Signs. Upon designation of a parking stall or stalls for the exclusive use of electric vehicles pursuant to Section 2, above, the General Services Department shall place signs or markings giving adequate notice that the parking stall or stalls are restricted and to be used only for such electric vehicles.
- 4. The Director of General Services may implement, modify, or eliminate a "Dwell Fee" for parking in an Electric Vehicle Charging Station Stall for more than four hours between the hours of 7:00 AM 9:00 PM. The amount of such Dwell Fee, if any, shall not exceed \$0.10 per minute for each minute after the first 240 minutes that a vehicle is parked in an Electric Vehicle Charging Station Stall between the hours of 7:00 AM 9:00 PM each day.
- 5. The "Fixed Fee" for charging an electric vehicle in an Electric Vehicle Charging Station Stall shall be \$0.18 per kWh.
- 6. The "Electricity Fee" for charging an electric vehicle in an Electric Vehicle Charging Station Stall located at one of the sites in the table below (each a "Site") shall be as specified in the table below for such Site, subject to semi-annual adjustment by the General Services Director in accordance with Section 8, further below:

- 7. The initial Electricity Fee for charging an electric vehicle in an Electric Vehicle Charging Station Stall located in an off-street public parking facility owned or operated by the County at a location other than one of the 16 Sites specified in Section 6 above, shall be a price per kWh that is equal to the average Electricity Fee for the 16 Sites specified in Section 6, above, over the course of the 12-month period immediately preceding the designation of such stall as an Electric Vehicle Charging Station Stall.
- 8. The Board of Supervisors hereby authorizes the General Services Director to adjust, no more than twice per fiscal year, the amount of the Electricity Fee for charging an electric vehicle in an Electric Vehicle Charging Station Stall located in off-street public parking facilities owned or operated by the County. The amount of each such Electricity Fee adjustment shall be based on the average unit cost (kWh) of electricity to the County for that Site over the most recent twelve-month period.
- 9. This Resolution supersedes Resolution No. 25-76.
