The Public Works Department requests to modify the Board Letter and Attachment B and add Attachment C to the May 14, 2024 Public Works Director's Report on Emergency Response Actions from Impacts of Flooding and Storms and Continuation of Emergency Actions, All Supervisorial Districts.

Recommended Actions:

That the Board of Supervisors:

- a) Receive and review a report from the Public Works Director regarding emergency actions taken pursuant to Resolution No. 19-327 and Public Contract Code section 22050 related to emergency operations responding to flooding, storms, debris removal and transportation projects following the recent 2023 and 2024 storm events (23STM1, 23STM2, 24STM1, 24STM2) and Refugio Road culvert repairs and the necessity of the action and the reasons the emergency will not permit delay resulting from competitive solicitation of bids;
- b) Determine that there is a need to continue the emergency actions ordered by the Public Works Director (4/5 vote required);
- c) Direct staff to return to the Board at the next regular meeting, or every 14 days in the case of consecutive weekly regular meetings, to allow the Board to review the emergency action and determine whether there is a need to continue the emergency action, by a 4/5 vote, until the actions are terminated; and
- d) Determine that the 2023 winter storms (23STM1 and 23STM2) emergency actions were found by the Board to be exempt from the provisions of the California Environmental Quality Act pursuant to State CEQA Guidelines Section 15269(d) on February 7, 2023. f) Determine that the Refugio Rd culvert repair emergency actions are statutorily exempt under the California Environmental Quality Act pursuant to State CEQA Guidelines Section 15269, as they involve specific actions to prevent and mitigate an emergency associated with a failed culvert threatening public road infrastructure, and direct the staff to file a Notice of Exemption with the Clerk of the Board of Supervisors on that basis.

### Summary Text:

This Board item reports on and recommends continuing the emergency actions and work being done pursuant to the Public Works Director's authority under Resolution No. 19-327 for the 2023 winter storms (23STM1 and 23STM2), the 2024 winter storms (24STM1 and 24STM2) and the Refugio Rd culvert repairs.

On December 17, 2019, the Board approved Resolution No. 19-327 pursuant to Public Contract Code section 22050(b)(1) which authorizes the Board by a 4/5th vote to delegate authority to the Public Works Director to take certain actions in the event of an emergency (see Attachment A).

Public Contract Code section 22050(b)(3) and (c)(2), requires the Public Works Department to regularly report on current emergency response work actions ordered by the Public Works Director pursuant to the delegated authority (see Attachment B). This allows the Board to comply with the statutory requirement to review the emergency action and determine by a four-fifths vote whether there is a need to continue the action.

Following the Board's initial review of the emergency actions, Public Contract Code Section 22050(c)(2) requires the Public Works Department to request that the Board review the emergency action at the next regular meeting, or every 14 days in the case of consecutive weekly regular meetings, and determine by a 4/5 vote that there is a need to continue the action until the action is terminated. Public Contract Code Section 22050(c)(3) requires terminating the action at the earliest possible date that conditions warrant so that the remainder of the emergency response can be completed through normal competitive bid procedures.

Disaster response and recovery processes are actively in progress. The extended timeframe of these operations are a result of the extent and severity of damage, the multi-jurisdictional collaboration at some damage sites, and staff's attention to federal procedures and guidelines to maximize reimbursement. Public Works is planning to continue emergency operations with expedited procurement to ensure public safety and access to roadways and prevent from further exacerbation of vulnerable locations across the county.

### **Background:**

On December 17, 2019, your Board explicitly authorized the Public Works Director, or designee, to take action whenever an Emergency occurs whether or not the Emergency results in a declared emergency. This Resolution defines Emergency as "a sudden, unexpected occurrence that poses a clear and imminent danger, requiring immediate action to prevent or mitigate the loss or impairment of life, health, property, or essential public services" (Pub. Contract Code § 1102.)

Public Contract Code section 22050(a)(1) provides that in the case of an emergency, a public agency, pursuant to a four-fifths vote of its governing body, may repair or replace a public facility, take any directly related and immediate action required by that emergency, and procure the necessary equipment, services, and supplies for those purposes, without following otherwise-applicable competitive bid procedures. Section 22050(b)(1), authorizes that the Board of Supervisors, by a four-fifths vote, may delegate, by resolution, to the appropriate county administrative officer, chief engineer, or other nonelected agency officer, the authority to order any Action.

While the Public Works Department was working to complete the emergency actions in response to the 2023 winter storms (23STM1 and 23STM2), the recent 2024 winter storms (24STM1 and 24STM2) have required additional emergency actions under Public Contract Code section 22050(a)(1). Public Works will utilize existing contracts procured on an emergency basis to respond to the new emergencies to the extent feasible, and Public Works will continue to report to the Board on the need to continue responding on an emergency basis until all emergency response actions have concluded.

Additionally, on March 12, 2024, staff discovered roadway damage on Refugio Road near the entrance of Refugio State Park. Upon further inspection, it was determined the culvert that runs under the road failed and material have washed out from under the road. We anticipate numerous cavities under the roadway which can cause sinkholes and total road failure. Public Works staff is working in conjunction with State Parks to repair the culvert and is actively working with the Contractor to start work.

### Fiscal Analysis:

### Narrative:

The Board of Supervisors, on November 7, 2023, approved a temporary loan in the amount of \$22,406,200 in order to continue work on the Transportation disaster projects associated with the 23STM1 and 23STM2 declared disasters. The department is working with OEM and the CEO to actively pursue disaster funding to reimburse costs associated with declared disasters. Continuing expedited procurement helps avoid delays to restored services and potential reimbursement.

The Department anticipates an additional \$8 million of work will be required following the early February 2024 storms, 24STM1 and 24STM2.

The Refugio Road culvert repair total construction costs, including contingencies, amounts to \$232,230. California State Parks is contracting and funding \$153,560 of the cost. The County portion is \$78,670 and will be funded using Measure A that is part of the storm damage appropriation already budgeted.

WHEREAS, the California Public Contract Code<sup>1</sup> section 1102, "Emergency" means a sudden, unexpected occurrence that poses a clear and imminent danger, requiring immediate action to prevent or mitigate the loss or impairment of life, health, property, or essential public services;

WHEREAS, history has shown that in certain circumstances Emergencies can evolve into a local, state, or federally declared disaster or state of emergency;

WHEREAS, the Public Works Department, on behalf of the County of Santa Barbara, the Santa Barbara County Flood Control and Water Conservation District, the Santa Barbara County Water Agency, and the Laguna County Sanitation District, is prepared to undertake immediate emergency response actions, in coordination with the County Executive Office, and if an emergency is declared with the Office of Emergency Management, and seek reimbursement, if available from the state and federal agencies; and

WHEREAS, Section 22050(a)(1) provides that in the case of an emergency, a public agency, pursuant to a four-fifths vote of its governing body, may repair or replace a public facility, take any directly related and immediate action required by that Emergency, and procure the necessary equipment, services, and supplies for those purposes, without giving notice for bids to let contracts ("Action");

WHEREAS, pursuant to Section 22050(b)(1), the Board of Supervisors/Directors, by a four-fifths vote, may delegate, by resolution, to the appropriate county administrative officer, chief engineer, or other nonelected agency officer, the authority to order any Action ("Delegated Authority");

WHEREAS, if a person with Delegated Authority orders any Action that person shall report to the Board of Supervisors/Directors the reasons justifying why the Emergency will not permit a delay resulting from a competitive solicitation for bids and why the Action is necessary to respond to the emergency. (Pub. Contract Code § 22050(b)(3).);

WHEREAS, the Board of Supervisors/Directors shall initially review the Emergency Action not later than seven days after the Action, or at its next regularly scheduled meeting if that meeting will occur not later than 14 days after the Action, and at least every 14 days thereafter until the Action is terminated, to determine, by a four-fifths vote, that there is a need to continue the Action, unless the person with Delegated Authority has terminated that Action prior to the Board of Supervisors'/Directors' review and determination (Pub. Contract Code § 22050(c)(2).);

WHEREAS, the continued Delegated Authority to order any Action in the case of an Emergency is hereby made a part of the emergency procurement policy of the County, Districts, and Agency;

WHEREAS, the Board of Supervisors/Directors desires that in the case of an Emergency the Public Works Director, or his or her designee, has the Delegated Authority to take Action;

WHEREAS, the Board of Supervisors/Directors previously delegated emergency authority under Board Resolution No. 15-321 on December 15, 2015, but now desires to supersede and replace that delegation and provide direction for its use as set forth above for all future Emergencies.

**NOW, THEREFORE,** the Board of Supervisors of Santa Barbara County, the Board of Directors of the Santa Barbara County Flood Control and Water Conservation District, the Board of Directors of the Laguna County Sanitation District, and the Board of Directors of the Santa Barbara County Water Agency, State of California, does resolve as follows:

1. "Emergency" means a sudden, unexpected occurrence that poses a clear and imminent danger, requiring immediate action to prevent or mitigate the loss or impairment of life, health, property, or essential public services;

Section 22050(a)(1) provides that in the case of an emergency, a public agency, pursuant to a four-fifths vote of its governing body, may repair or replace a public facility, take any directly related and immediate action required by that Emergency, and procure the necessary equipment, services, and supplies for those purposes, without giving notice for bids to let contracts ("Action");

- The Public Works Director, or his or her designee, shall report to the Board of 6. Supervisors/Directors the reasons justifying why the Emergency will not permit a delay resulting from a competitive solicitation for bids and why the Action is necessary to respond to the emergency. (Pub. Contract Code § 22050(b)(3).); and
- 7. The Public Works Director, or his or her designee, shall report to the Board of Supervisors/Directors not later than seven days after the Action, or at its next regularly scheduled meeting if that meeting will occur not later than 14 days after the Action, and at least every 14 days thereafter until the Action is terminated, to determine, by a four-fifths vote, that there is a need to continue the Action, unless the person with Delegated Authority has terminated that Action prior to the Board of Supervisors'/Directors' review and determination. (Pub. Contract Code § 22050(c)(2).)
- 8. That the continued Delegated Authority to order any Action in the case of an Emergency is hereby made a part of the emergency procurement policy of the County, Districts, and Agency.

# **Emergency Work Actions**

### **Transportation Division**

Transportation has been responding to storm event 23STM1, 23STM2 under the Proclamation of Local Emergency declared by the Director of Emergency Services on January 9, 2023 and the Board Resolution 23-5, the Proclamation of a State of Emergency declared by the Governor on January 4, 2023, the Federal Emergency (EM3591-CA) and Federal Disaster (DR 4683) declared on January 14, 2023.

Transportation has been responding to storm event 24STM1, 24STM2 declared by the Director of Emergency Services on February 4, 2024 and Board Resolution 2415.

Transportation has been responding to a failed culvert on Refugio Rd which was discovered on March 12, 2024.

The following work to remove debris from various county roads; to clear culverts; to implement protective measures; and to perform emergency repairs must be completed on an emergency basis in order to establish emergency and public roadway access, to protect existing property and alleviate financial impacts. Use of competitive procurement proposals or formal bids or awarding would delay the urgent action required to address public safety, access and welfare.

### **General Reporting Summary**

Transportation engineering, maintenance, construction, and permits staff began assessing damage on January 9, 2023 and immediately began initiating emergency contracts to perform debris removal and implement emergency protective measures to establish emergency access; to regain access to isolated residents; and to protect existing transportation facilities and property.

Transportation engineering, maintenance, construction, and permits staff began assessing damage on February 4, 2024 and immediately began performing emergency protective measures by clearing debris to establish emergency access and protect the health and safety of others; regain access to remote residents while protecting existing transportation facilities and property; Assessments are on-going.

Additionally, on March 12, 2024, staff discovered roadway damage on Refugio Road near the entrance of Refugio State Park. Upon further inspection, it was determined the culvert that runs under the road failed and material have washed out from under the road. We anticipate numerous cavities under the roadway which can cause sinkholes and total road failure. Public Works staff is working in conjunction with State Parks to repair the culvert and is actively working with the Contractor to start work. As of May 10, 2024, a total of 238 damage sites have been identified and are currently being assessed to determine scope and cost. Details regarding 132 damage sites are captured under 23STM1. Details regarding 18 damage sites are captured under 23STM2. Details regarding 57 damage sites are captured under 24STM1. Details regarding 32 damage sites are captured under 24STM2. In total, 137 damage sites are within the Federal Emergency Management Agency (FEMA) jurisdiction and 102 Federal Highway Administration (FHWA) jurisdiction. Sites continue to be discovered. Preliminary assessments reveal more than \$74M to facilitate the necessary maintenance and repairs of the discovered damage sites. The team is focusing on prioritizing work and performing detailed technical assessments, and the estimated costs will be fine-tuned accordingly.

Under the aforementioned contracts and jurisdictions, Category A Debris Removal, and Category B Emergency Protective Measures and Emergency Opening work is being performed. This work remains critical as some County maintained roads are impassable due to large slipouts or slides, reducing the travel way width of some road segments to less than one lane. The following list of roads or segments of roads remained closed as of May 10:

**Project Description:** This Board item reports on and recommends continuing the emergency actions and work being done pursuant to the Public Works Director's authority under Resolution No. 19-327 for the 2023 winter storms (23STM1 and 23STM2) and the 2024 winter storms (24STM1 and 24STM2). This report adds Refugio Road culvert storm damage to list of emergency repair work listed in Attachment B.

Public Contract Code section 22050(b)(3) and (c)(2), requires the Public Works Department to regularly report on current emergency response work actions ordered by the Public Works Director pursuant to the delegated authority (see Attachment B). This allows the Board to comply with the statutory requirement to review the emergency action and determine by a four-fifths vote whether there is a need to continue the action.

Following the Board's initial review of the emergency actions, Public Contract Code Section 22050(c)(2) requires the Public Works Department to request that the Board review the emergency action at the next regular meeting, or every 14 days in the case of consecutive weekly regular meetings, and determine by a 4/5 vote that there is a need to continue the action until the action is terminated. Public Contract Code Section 22050 (c)(3) requires terminating the action at the earliest possible date that conditions warrant so that the remainder of the emergency response can be completed through normal competitive bid procedures.

Disaster response and recovery processes are actively in progress. The extended timeframe of these operations are a result of the extent and severity of damage, the multi-jurisdictional collaboration at some damage sites, and staff's attention to federal procedures and guidelines to maximize reimbursement. Public Works is planning to continue emergency operations with expedited procurement to ensure public safety and access to roadways and prevent from further exacerbation of vulnerable locations across the county.

### EXECUTIVE DEPARTMENT STATE OF CALIFORNIA

#### **PROCLAMATION OF A STATE OF EMERGENCY**

WHEREAS on February 4, 2024, I proclaimed a State of Emergency to exist in Los Angeles, Orange, Riverside, San Bernardino, San Diego, San Luis Obispo, Santa Barbara, and Ventura counties due to the early February 2024 winter storms; and

WHEREAS these severe winter storms also struck Alameda, Butte, Glenn, Lake, Mendocino, Monterey, Sacramento, San Francisco, Santa Cruz, Sonoma, and Sutter counties causing widespread river and coastal flooding, flash flooding, high surf conditions, mudslides, and debris flows threatening life and safety, structures, and other critical infrastructure; and

**WHEREAS** the impacts from these winter storms caused significant damage to highways and roadways and widespread damage to public property; and

WHEREAS these winter storms have predominantly impacted public infrastructure and resulted in significant costs to state and local governments; and

WHEREAS state and federal tax postponement is intended to provide targeted tax relief to individuals and businesses impacted by State-declared emergencies or disasters; and

**WHEREAS** under the provisions of Government Code section 8558(b), I find that conditions of extreme peril to the safety of persons and property exist due to these winter storms; and

WHEREAS under the provisions of Government Code section 8558(b), I find that the conditions caused by these winter storms, by reason of their magnitude, are or are likely to be beyond the control of the services, personnel, equipment, and facilities of any single local government and require the combined forces of a mutual aid region or regions to appropriately respond; and

WHEREAS under the provisions of Government Code section 8625(c), I find that local authority is inadequate to cope with the magnitude of the damage caused by these winter storms; and

**WHEREAS** under the provisions of Government Code section 8571, I find that strict compliance with various statutes and regulations specified in this Proclamation would prevent, hinder, or delay the mitigation of the effects of these winter storms.

**NOW, THEREFORE, I, GAVIN NEWSOM**, Governor of the State of California, in accordance with the authority vested in me by the State Constitution and statutes, including the California Emergency Services Act, and in particular, Government Code section 8625, **HEREBY PROCLAIM A STATE OF EMERGENCY** to exist in Alameda, Butte, Glenn, Lake, Mendocino, Monterey, Sacramento, San Francisco, Santa Cruz, Sonoma, and Sutter counties due to the impacts of these winter storms.

#### IT IS HEREBY ORDERED THAT:

- All operative provisions contained in my February 4, 2024, State of Emergency Proclamation are hereby incorporated and applicable to Alameda, Butte, Glenn, Lake, Mendocino, Monterey, Sacramento, San Francisco, Santa Cruz, Sonoma, and Sutter counties as a result of the storms identified in this and the previous Proclamation.
- 2. The California Department of Transportation shall formally request immediate assistance, as appropriate, through the Federal Highway Administration's Emergency Relief Program, United States Code, Title 23, section 125, in order to obtain federal assistance for highway repairs, reconstruction, or restoring access to roadways impacted by these winter storms.
- 3. The restrictions set forth in Penal Code section 396, which are automatically triggered upon proclamation of a State of Emergency, are suspended, and no such restrictions are imposed, for Alameda, Mendocino, San Francisco, and Sonoma counties in connection with these winter storms.
- 4. Revenue and Taxation Code section 18572, relating to the postponement of certain tax-related deadlines pursuant to Internal Revenue Code section 7508A, is suspended and shall not apply in connection with an Emergency Declaration or Presidential Major Disaster Declaration providing only Public Assistance in response to these winter storms and/or the State of Emergency proclaimed on February 4, 2024, and herein in connection with these winter storms.

**I FURTHER DIRECT** that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.

This Proclamation is not intended to, and does not, create any rights or benefits, substantive or procedural, enforceable at law or in equity, against the State of California, its agencies, departments, entities, officers, employees, or any other person.
