Executive Summary and Discussion:

This project is one of the strategies the Department employs in its annual Preventive Maintenance Program and consisted of the application of a asphalt slurry on the existing pavement surface at various locations throughout Santa Barbara County. This contract completed the slurry seal application phase of the Preventive Maintenance Program for 2002/2003. Approximately 53 lane miles of County maintained roadway was resurfaced with construction of this project.

The Board approved the project as part of the 2002/2003 Capital Improvement Plan. The specific project locations were approved by The Board in the FY 2002/2003 Road Maintenance Annual Plan. See Attachment A for a list of streets


