WHEREAS, the COUNTY OF SANTA BARBARA, a political subdivision of the State of California, (hereinafter "COUNTY"), is the fee owner of a portion of Orcutt Road, a developed roadway in the County of Santa Barbara, State of California; and

WHEREAS, in order to accommodate the State of California Department of Transportation's (Caltrans) operation and maintenance of the future State Route 135/Union Valley Parkway intersection, COUNTY is accepting ownership and maintenance of the improvements (culvert, headwalls, and rock slope protection) identified in Exhibit A, within Caltrans and County future easements in order to assure proper drainage and engineered function of said culvert.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Santa Barbara, State of California does hereby find, and declare as follows:

1. The above recitals are true and correct.
2. The Santa Barbara County Board of Supervisors does hereby declare its intention to own and maintain the improvements identified in Exhibit "A" and attached hereto and incorporated herein by reference, near the State Route 135/Union Valley Parkway intersection, in the County of Santa Barbara, California.




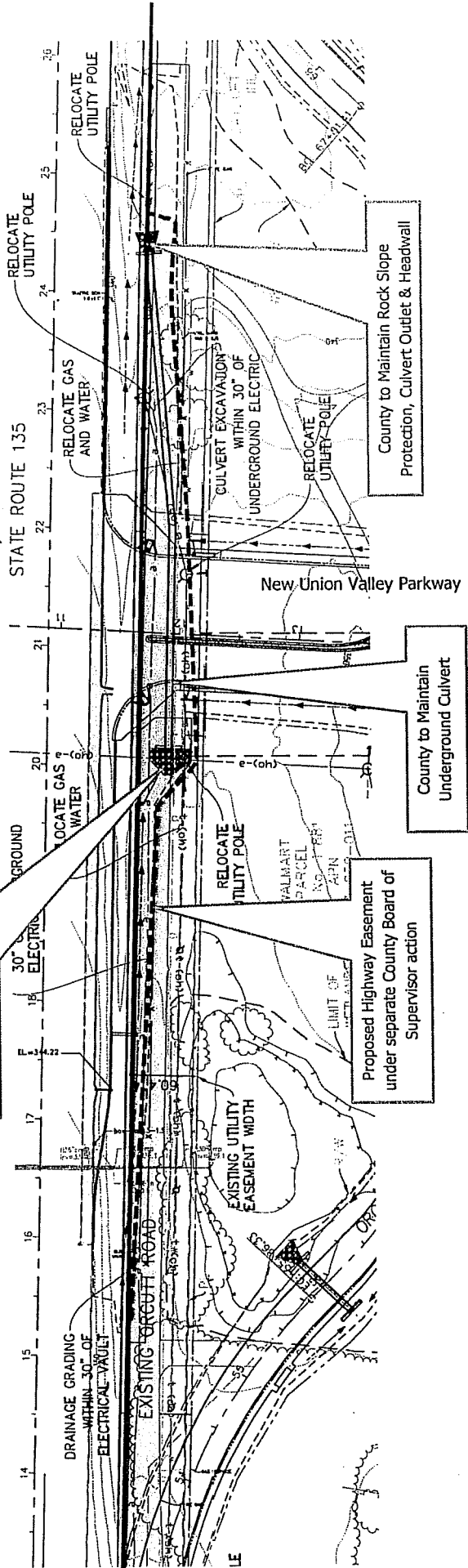
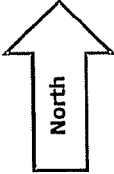
