Title: Increase Appropriations in the Public Works Fund 1930

Budget Action: Increase appropriations of \$4,800,000 in the Public Works Resource Recovery and Waste Management Enterprise Fund for Capital Assets funded by the release of

Retained Earnings.

Justification: On June 19, 2024, the Central Coast Regional Water Quality Control Board (CCRWQCB) informed RRWMD that the procedures listed in the Water and Wastewater

Management Plan, previously approved in 2021 are not sufficient to prevent the discharge of wastewater from the CMU. Due to ongoing water quality concerns, the RRWMD submitted a revised Technical Report on June 24, 2024 which included a revised Water and Wastewater Management Plan and proposed to construct an Active Treatment System (ATS) where treated discharges will be covered under the CCRWQCB's National Pollutant Discharge Elimination System (NPDES) General Permit for Discharges with Limited Threat to Water Quality (Order No. R3-2022-0035, NPDES No. CAG99304). This work is required to comply with the State Water Resources Control Board, General Waste Discharge Requirements for Composting Operations Order WQ 2020-0012-DWQ ("Compost Order"). This budget revision is required to

fully fund the engineering design costs, procurement of the ATS, its installation, and associated piping, electrical and pump systems.
