- 2) ADMHS Audit Reserve \$846,000
- 3) Jail Sewer main repair \$523,000
- 4) District Attorney/Public Defender ratio preservation \$400,000

Conceptually approve funding of items 6 through 13 and 21, Attachment E, Board adjustments to FY 2008-09 Recommended Budget as follows:

- 8) SB Visitors and Conference Bureau (Film Commission) \$95,000
- 9) Agricultural Commissioner (Oak Tree Specialist) \$107,000
- 10) Agricultural Commissioner (Ag Advisory Committee) \$100,000
- 11) Public Health (Environmental Health Fee Waiver) \$107,000
- 12) Planning and Development (Ag Planner) \$119,000
- 13) Public Health (Cuyama Clinic) \$92,000
- 21) Fire Mapping \$40,000

Further directed the transfer of the Adult and Aging Network to the Social Services Department to be funded out of the \$121,000 allocated to the Public Health Geriatric Assessment Program.

15) District Attorney (Truancy Intervention Program) - \$50,000

Transition funding contingent upon County staff meeting with County Schools to discuss options for full funding of the program with continuation of the program potentially contingent on participation by County Schools. Directed staff to return to the Board with a status report in three months as appropriate.

Conceptually approved all final budget adjustments, Attachment E, Board adjustments to FY 2008-09 Recommended Budget, including #5) ADMHS Restoration - \$3,300,000. The Board approved FY 2008-09 allocation for ADMHS will provide funding in excess of \$8,000,000 above the adopted FY 2007-08 budget. Directed the County Executive Office to return to the Board with recommended budget adjustments after the 1st quarter of FY 2008-09 and after impacts to the County by the adoption of the State Budget are known.
