# Affordable Housing & Federal Funding

## History: Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME) funds

---

### AFFORDABLE HOUSING

- No more than 30% of the monthly household income for rent and utilities.
- Affordable developments are built for households based on the area median income (AMI).

<b>Income Limit</b> <i>4-person household</i>
Extremely Low (30% AMI): \$37,450
Very Low (50% AMI): \$62,450
Low (80% AMI): \$100,050

### CDBG & HOME

#### Community Development Block Grant (CDBG)

- Local communities undertake community development activities ranging from housing and neighborhood revitalization to economic development and infrastructure improvement.

#### HOME Investment Partnerships Program (HOME)

- Local communities use the funds for a variety of homeownership and rental activities.

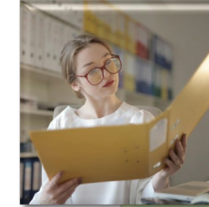
