QUITCLAIM DEED AGREEMENT

The COUNTY OF SANTA BARBARA, a political subdivision of the State of California, and the SANTA BARBARA COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT, a dependent special district (herein collectively the "Grantor"), as easement holder does hereby remise, release and forever quitclaim to:

Cornelius J. Van Wingerden and Jeanette Lynn Van Wingerden, Trustees of the Van Wingerden Family Trust dated May 13, 1999 (herein the "Owners");

all right, title and interest in a portion of the right-of-way granted to the County of Santa Barbara and the Santa Barbara County Flood Control and Water Conservation District by that certain Grant Deed recorded as Instrument number 21125, in Book 2198 pages 739-745, on July 25, 1967. The area being quitclaimed is identified on page 3 of the above Grant Deed as "Parcel 2.1" which area shall herein be identified as the "Portion." A sketch showing the approximate location of the Portion is attached hereto and made a part hereof.

This quitclaim does not impact the other easement areas granted to Santa Barbara County or to the Santa Barbara County Flood Control and Water Conservation District via the above referenced Grant Deed.

Owners specifically acknowledge that Grantor has transferred and Owners have accepted the Portion on an "AS IS WITH ALL FAULTS" basis and that Owners did not rely on any representations or warranties of any kind whatsoever, express or implied, from Grantor, its employees, agents, or brokers as to any matters concerning the Portion, including without limitations: its physical condition, including the structural elements of any improvements; its geology; the development potential of the Portion and its use, habitability, merchantability, or fitness for a particular purpose; its zoning or other legal status; its compliance with law; the presence or removal of hazardous or toxic materials, substances, or wastes on, under or about the Portion or the neighboring properties; the quality of labor or materials used in any improvements; the conditions of title to the Portion; leases, service contracts, or other agreements affecting the Portion; and the economics of the operation of the Portion.
