Recommended Actions:

That the Board of Supervisors:

- a) Approve and execute a Memorandum of Understanding (MOU) authorizing General Services Vehicle Operations to perform contract maintenance and repair work on vehicles owned and operated by Mission Hills Community Service District (MHCSD);
- b) Authorize General Services Vehicle Operations to provide fuel, vehicle maintenance and vehicle repair services on vehicles owned by MHCSD; and
- c) Find that the proposed action does not constitute a "Project" within the meaning of California Environmental Quality Act (CEQA), pursuant to 14 CCR 15378(b) (2) (continuing administrative or maintenance activities).

Summary Text:

The Board's action will enable General Services Vehicle Operations the ability to assist MHCSD with vehicle maintenance and vehicle repair services on the thirteen (13) vehicles owned by the MHCSD. The Board's action will also allow General Services Vehicle Operations the ability to sell fuel to MHCSD for their fleet vehicles.

Background:

In an effort to better serve the community and provide cost effective maintenance service and fuel to a smaller governmental agency, Santa Barbara County Vehicle Operations recommends entering into this agreement with the MHCSD.

In accordance with the MOU between Santa Barbara County and MHCSD, Santa Barbara County would perform contracted vehicle maintenance and repair work for MHCSD. The contracted work would include the maintenance and repair of the District's thirteen (13) fleet vehicles.

Through this agreement Santa Barbara County would provide fuel from the County's fueling station(s) for MHCSD's vehicles.

MHCSD understands that Vehicle Operations has retained the right to prioritize work and service the equipment owned by Santa Barbara County first, when appropriate.

Fiscal and Facilities Impacts:

Santa Barbara County shall bill the MHCSD monthly for all services rendered within the billing period. Payments will be made by check upon receipt of invoice. The minimal workload increase will have no effect on Vehicle Operations staffing levels.

Fuel purchased by MHCSD under this agreement for MHCSD's thirteen (13) fleet vehicles will help off-set the operational costs of the County's Lompoc fueling stations located on Sweeney Road.

The additional workload created by this agreement will be minimal and will generate a small revenue stream to the County. The agreement between Santa Barbara County and MHCSD will be beneficial to both parties.
