This exchange gives the County the flexibility to use these funds for a wide range of transportation projects. The Federal mandates associated with Federal funds are not applicable to funds converted to State Highway Account dollars; therefore, these funds can be used without Federal restrictions The re-allocation of funding is not a project by definition. The term project refers to the activity which is being approved and which

nay be subject to several discretionary approvals by governmental agencies. The term project does not mean each separate governmental approval.
