SECOND AMENDMENT

THIS IS THE SECOND AMENDMENT (hereafter referred to as Second Amendment) to the Agreement for Services of Independent Contractor for Temporary Personnel Services, by and between the County of Santa Barbara (COUNTY) and Robert Half International (Robert Half) (the "Agreement").

WHEREAS, the Agreement is effective through June 30, 2022; and

WHEREAS, the parties desire to amend the Agreement to add funding of \$325,000 for Fiscal Year 2021-2022 for a total contract amount of \$1,125,000; and

WHEREAS, this Amendment incorporates the terms and conditions set forth in the Agreement, approved by the County of Santa Barbara on June 8, 2021, and the First Amendment approved by the County of Santa Barbara on September 14, 2021;

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. **Amendment.**

a. The Agreement is amended as follows:


The Not-to-Exceed Amount in Section A is updated from \$800,000 to \$1,125,000 for the duration of the contract.




